ORDER

As a part of streamlining and incorporating updations in the extant process of Entrepreneur selection process for Akshaya Centres, it has been decided to amend the Government order read above. Having examined the matter, Government are pleased to order the following modifications in the Annexure 1 to the Government Order read above:

(i) under the sub title ' Selection Committees' the details are substituted as below:-

Selection Committee of Akshaya Entrepreneurs at the District Level shall have the following members.

1. District Panchayat President/Municipal Chairman/Corporation Mayor (belongs to the respective locations of LSGI) - Chairman.
2. Sub Collector/Assistant Collector nominated by the concerned District Collector - Member.
3. Grama Panchayat President Concerned/ or the Councillor of concerned Municipality/Corporation area - Member
4. Representative of lead Bank/Service Area Bank Manager of respective District - Member
5. Secretary/Assistant District Co-ordinator Akshaya Project Office of the respective District - Convener.

Appeals Committee (First Appeals should be submitted with in 14 days from the date of publishing the list).

1. District Collector - Chairman
2. District planning Officer - Member

Second Appeal should be filed before the Director, Kerala State IT Mission , Thiruvananthapuram within 7 days of the order of the first appeal.

(ii) Under the Sub title "units that can be considered as Akshaya Centre without going through the Entrepreneur Selection Process" item 1 Kudumbasree Units is deleted and substituted as below:-

"1. The Kudumbasree IT units having specified software, hardware, space and willing to operate an Akshaya Centre can participate in the selection process of Akshaya centres."

(iii) Under the subtitle "Selection Procedure for Entrepreneurs" the following condition is inserted:-

"17. There shall be 10% reservation to SC/ST Communities in the allotment of Akshaya Centre".

2. The Government Order read above stands modified to the above extent.
