ORDER

Government of India have constituted a Unique Identification Authority of India (UIDAI) for the issue of Unique ID number to the residents of India, to ensure better delivery of services and welfare schemes to the people especially the poor and marginalised. IT Department has been nominated as the Nodal Department and KSITM was nominated as the Nodal Agency for implementation of the project.

2. The project was launched in Kerala on 24-02-2011. KSITM has initially empanelled 3 enrolling agencies namely Akshaya, Keltron and IT@ School. Around 2.75 Crore people have been covered under Aadhaar and 2.18 Crore Aadhaar Number has been generated so far. UIDAI, Government of India sanctioned Rs. 50/- per successful enrolment. As per GO read as first paper above rate for Aadhaar enrolment to enrolment agencies has been fixed. The existing breakup details of service charge per successful enrolment is as follows:

KSITM	Rs. 10/-
Akshaya Enterpreneurs	Rs. 35/-
Akshaya State Office	Rs.3/-
Verifier	Rs.2/-
Total	Rs. 50/-

- 3. As per sanction order, order read as second paper above it is shown that Phase-II enrolment will be paid only at the rate of Rs. 40/- per registration, that means UIDAI has cut the enrolment rate by Rs. 10.
- 4. As per representation read as 3rd paper above Akshaya entrepreneurs have requested Government to retain existing service charge to Rs. 35 and not to deduct Rs.10 from their share, otherwise they will end up in huge financial crisis.
- 5. As per letter read as 4th and 5th papers above Director Akshaya and Director KSITM respectively have recommended to restructure the payment pattern retaining Rs.35 to Akshaya entrepreneurs to avoid hardship for them.
- 6. After having examined the matter in details Government are pleased to order that the service charge payable to Akshaya Entrepreneurs will remain Rs. 35/- per successful Aadhaar enrolment in Phase II of enrolment as in the case of Phase I. Accordingly the service charge payment pattern is revised as given below in Phase II of Aadhaar enrolment.
